I was on the Board of the Washington State Progressive Caucus. I wrote a People's Bill of Rights which included nearly all of the Green Party 10 Key Values.

2a. Describe at some length your experience with at least three of the Green Party Ten Key Values. **Non-violence:** I opposed the Vietnam War as a teenager. As an adult, I spent 20 years teaching courses in Non-violent conflict resolution using the ideas of Gandhi.

Decentralization: I am in favor of local control of public schools.

Grassroots Democracy: I have ran several political campaigns including one where I used grassroots organizing to defeat a billionaire funded candidate who outspent me by more than 40 to 1.

Ecological wisdom: I wrote a book about saving the environment called Snowbirds a Story of Hope which you can download for free on my personal website (David Spring dot org). The story is based in part about my successful legal efforts to save the spotted owls in the early 1990s. See also another one of my websites called the Washington Environmental Protection Coalition dot org. where I explain the history of that effort.

I do not have a criminal record. I have a Bachelors Degree in Science Education from Washington State University and a Masters Degree in Child Development from the University of Washington. I spent 20 years teaching at the University of Washington. I currently teach courses in starting your own business at schools in Whatcom county.

- 3a. Your campaign plans and goals:

My campaign plan is to run an online campaign opposing the current Superintendents shutdown of every school in our state for three months (the first time this has ever happened). I am also opposed to his failure to adequately fund our schools.

- 3b. Research on voters in your district or state: I have ran for office five times so far. I have made it past the primary four times and nearly won twice. I have knocked on more than 30,000 doors in East King County. I think parents did not want their schools shutdown.
- 3c. Use of volunteers, including but not limited to your initial campaign support group: I have had dozens of volunteers in past campaigns. Time will tell if people will want to support my campaign this time.

I do not believe in raising money. I am more interested in recruiting volunteers.

I typically put about 20 hours per week in research and posting articles to my campaign website and sending out newsletters to my supporters.

I wrote a book on the scientific research on the corona virus. You can read the book for free by going to commonsensebook.org. It explains why the current superintendent was wrong to shut down every public school in our state.
